Lecture 13 - Atoms with many electrons

Abstract

After our discussion of extremely simple atoms like hydrogen and helium, we will now discuss the most important properties of more complex atoms. We will see, how we can categorize them and discuss some of the general properties

We started the discussion of atoms in lecture 3 by an extremely simple and powerful model, the two-level system (Jendrzejewski et al., a). We then moved on to discuss how it can emerge within the hydrogen atom and the Helium atom. For both of these we dived again into simplified schemes. Especially for Hydrogen, we saw in lecture 7 the exploding complexity of the models as we tried to describe it (Jendrzejewski et al., b). If we now want to leave these rather academic problems and turn to the other widely used atoms, molecules etc, we have towards effective models for two reasons:

- Analytical solutions do not exist.
- Full numerical solutions become extremely and expansive.

A particularly instructive discussion of the ineffeciency of brute force numerical methods was given by Kenneth Wilson, the father of the renormalization group, in Sec 3 of (Wilson, 1975).




Figure 1: A toy model, exemplifying the problem of direct numerical analysis

The main idea is plotted in Fig. 1 and its description in the words of Kenny Wilson can be found in Fig. 2.

First consider the space of states of the system. One starts on an energy scale of 1 eV with two states, a ground state and an excited state. One might set up Pauli matrices σ_{0x} , σ_{0y} , σ_{0z} to be the operators on this space. Next one brings in the energy scale 0.1 eV; on this scale each state splits into two, giving four states total. A new set of Pauli operators σ_{1x} , σ_{1y} , σ_{1z} can describe the splitting. One splits each state into two again on the scale 0.01 eV, introducing operators σ_{2x} , σ_{2y} , and σ_{2z} .

Suppose one has 11 energy scales in toto: 1, 0.1, 0.01 eV etc., down to 10^{-10} eV. Then there are 11 sets of Pauli matrices and 2,048 states after the final splitting.

Secondly, consider the Hamiltonian of the system. The Hamiltonian must have 11 separate terms corresponding to the 11 energy scales:

$$\mathcal{H} = \mathbf{H_0} + 0.1\mathbf{H_1} + 0.01\mathbf{H_2} + \dots + 10^{-10}\mathbf{H_{11}}.$$
 (1)

The operator \mathbf{H}_0 gives the unperturbed energies of the original two states (Fig. 1). In other words, \mathbf{H}_0 depends only on $\bar{\sigma}_0$; \mathbf{H}_0 can be represented by a 2×2 matrix. For example, \mathbf{H}_0 might be

$$\mathbf{H}_0 = \begin{vmatrix} 1 & 2 \\ 2 & -1 \end{vmatrix}. \tag{2}$$

The operator $\mathbf{H_1}$ determines the first set of energy level splittings (Fig. 2); $\mathbf{H_1}$ depends on both $\bar{\sigma}_0$ and $\bar{\sigma}_1$ and can be represented by a 4 × 4 matrix. See, e.g., Eq. (6) below. Similarly, $\mathbf{H_2}$ is represented by an 8 × 8 matrix, etc.; $\mathbf{H_{11}}$ is represented by a 2,048 × 2,048 matrix.

The full Hamiltonian \mathcal{H} , like \mathbf{H}_{11} , is represented by a 2,048 \times 2,048 matrix. Assuming this matrix has been constructed, one's first temptation (especially if one is at Los Alamos) might be to feed it to the 7600 and go fishing.

This is not the most economical procedure. A $2,048 \times 2,048$ matrix is rather large; diagonalizing it would require several hours of computing

We will come back to different experimental approaches to solve problems for which we cannot devise effective theories at a later stage, when we discuss quantum simulation and quantum computation with atomic systems. But first we will try to gain a good understanding of atoms with many electrons.

1 Atoms with Many Electrons

As already discussed before, the N electron system cannot be solved in its full complexity, so we have to walk through the different levels of physical effects to understand what is going on. We will start out with the simplest model, which consists of

- N electrons without spin
- Bound to the point-like nucleus of charge Z, which is supposed to be not moving.

In natural units, the Hamiltonian can be written as:

$$\hat{H} = \sum_{i}^{N} \left(-\frac{1}{2} \vec{\nabla}_{r_i}^2 - \frac{Z}{r_i} \right) + \sum_{i < j} \frac{1}{r_{ij}}.$$
 (1)




Figure 3: Charge distribution of three electrons bound to the nucleus.

The system is visualized in Fig. 3.

As before the Hamiltonian has two contributions:

- The well understood binding of each electron to the nucleus, which allows us to make the connection with the hydrogen orbitals.
- The interaction between the electrons, which couples all the orbitals.

How can we deal with the $1/r_{ij}$ terms? If many electrons are contained in the system we cannot ignore the influence of the electron-electron interaction on the system, which was already a questionable approximation in the Helium atom (Jendrzejewski et al., c).

2 Central Field Approximation

But we can bring back the system to the well-known problems with spherical symmetry by splitting the interaction into two parts. One will be assumed to have spherical symmetry and will be written as $\sum_i S(r_i)$ and the rest will be treated as a perturbation. So we obtain the Hamiltonian:

$$\hat{H} = \hat{H}_s + \hat{H}_1 \tag{2}$$

$$\hat{H}_s = \sum_{i}^{N} \left(-\frac{1}{2} \vec{\nabla}_{r_i}^2 + V_{\text{cf}}(r_i) \right) \tag{3}$$

$$V_{\rm cf}(r_i) = -\frac{Z}{r_i} + S(r_i),\tag{4}$$

The perturbation is then difference between the spherically symmetric part of the interaction and the true electron-electron interaction:

$$\hat{H}_1 = \sum_{i < j} \frac{1}{r_{ij}} - \sum_i S(r_i) \tag{5}$$

 $S(r_i)$ describes now the screening of the nucleus due to the other electrons. This function interpolates between (see 4):

$$V_{\rm cf}(\vec{r}_i) = \begin{cases} -\frac{Z}{r_i} & \text{for } r \to 0\\ -\frac{Z-N+1}{r_i} & \text{for } r \to \infty \end{cases}$$
 (6)

- For very small distances the electron mainly sees the strong attraction of the nucleus.
- For very large distances the other electrons mostly screen the charge of the nucleus and electron feels the 1/r potential of the hydrogen atom.




Figure 4: The screening as a function of distance.

We can now focus on the study of the part with spherical symmetry \hat{H}_s . Given its symmetry, we can once again use the conservation of orbital angular momentum (see Lecture 5 (Jendrzejewski et al., d)). As a result, the wave function can be a product state of single-particle wave functions:

$$\psi_{\rm cf}(\vec{r}_1, \cdots, \vec{r}_{\rm n}) = \psi_1(\vec{r}_1) \cdot \psi_2(\vec{r}_2) \cdot \cdots \cdot \psi_{\rm n}(\vec{r}_{\rm n}), \tag{7}$$

where $\psi_i(\vec{r}_i)$ are solutions of the Schrödinger equation:

$$\left(-\frac{1}{2}\vec{\nabla}_{\vec{r}_i}^2 + V_{\rm cf}(r_i)\right)\psi_i(\vec{r}_i) = E_i\psi_i(\vec{r}_i). \tag{8}$$

 ψ_i can be split up into a radial and an angular part:

$$\psi_i = \psi(nlm)_i = Y_{lm}(\theta, \varphi) \cdot R_{nl}(r). \tag{9}$$

For the radial part we get $u(r) = r \cdot R(r)$. Thus, u(r) solves the radial Schrödinger equation:

$$\left(-\frac{1}{2}\frac{d^2}{dr^2} + V_{\rm cf}(r) + \frac{l(l+1)}{2r^2}\right)u_{nl} = E_{nl}u_{nl}(r).$$
(10)

The major difference to the H atom is that the degeneracy of the l levels is lifted because of $V_{\rm cf}$.

2.1 On the determination of the effective potential

We will not discuss here the different techniques to derive the central field in detail as this is quickly diving into the different numerical techniques of many-body systems. A first discussion of the different approaches can be found in chapter 10 of (Hertel and Schulz, 2015a). The different levels of sophistication are:

- The *Thomas-Fermi* model, which assumes that the N electrons behave like a Fermi gas inside the Z/r potential.
- The Hartree method, in which the effective potential is iteratively recalculated based on the obtained solutions to the radial Schrödinger equation.
- The Hartree Fock method, in which we also take into account the proper symmetrization of the wavefunctions.

3 Filling up the shells

If we can ignore the spin for the determination of the energy levels, we have the following quantum numbers:

- n, which is electron shell.
- l, which is the orbital angular momentum with l < n.
- s, which is the spin of the electron and it can be $\pm 1/2$




Figure 5: Periodic table as taken from (com)

As the electrons are fermions we can fill up each of the nl states with two of them. We then write down the configuration of the electron by writing down the numbers of electrons per nl configuration. So we get the periodic table shown in Fig. 5. We will typically use the following notation:

- A configuration is the distribution of the electrons over the different orbits.
- Electrons with the same n are part of the same *shell*.
- Electrons with the same n and l are part of the same sub-shell.
- The inner shells are typically filled and form the *core*.
- The outermost shell is typically named the *valence* shell.

4 Alkali Atoms

Alkali atoms are the simplest to understand and widely used in the field of laser cooling. The electron configurations are

Examples.

- Li: $1s^22s$
- Na: $1s^2 2s^2 2p^6 3s$
- K: 1s²2s²2p⁶3s²3p⁶4s, so we fill up the 4s orbitals before the 3d orbitals.
- Rb: $1s^22s^22p^63s^23p^63d^{10}4s^24p^65s$, so we fill up the 5s orbitals before the 4d and 4f orbitals.
- Cs: $1s^22s^22p^63s^23p^63d^{10}4s^24p^64d^{10}5s^25p^66s$, so we fill up the 6s orbitals before the 4f, 5d and 5f orbitals.

This structure can be nicely understood by the idea of screening as introduced in the central field approximation. Consider for example the Na for which one electron has to be on the third shell. Within the hydrogen atom the 3s, 3p and 3d are degenerate, however the screening will lift this degeneracy.

- Electrons in the s-shell spend a lot of time close to the nucleus and fill a strong binding potential, i.e. they have a low energy.
- On the other extreme the electrons in the d-shell have large angular momentum, which hinders them from getting close to the core. The 10 electrons can therefore efficiently screen the nucleus from the electron. The energy of the d shell is therefore quite close to the energy of the hydrogen atom.

For K the same principle applies.

- The 4s orbital is strongly shifted down to the strong nuclear potential.
- The 3d orbital is well screened by the other electrons, such that it is of higher energy than the 4s orbit.

We can describe this effect empirically through the *quantum defect*. We simply write down the energy levels as:

$$E_{nl} \cong -R_{y,\infty} \cdot \left(\frac{1}{n-\delta_l}\right)^2,\tag{11}$$

where δ_l is the quantum defect for a certain value of l. Some examples are summarized in Fig. 6.

The effect of the quantum defect is actually so substantial that it introduces optical transitions between the different subshells of Alkali atoms.

- $\bullet\,$ For Li there is a $2s\to 2p$ transition at 671 nm.
- \bullet For Na there is a $3s \to 3p$ transition at 589 nm.
- \bullet For K there is a $4s \to 4p$ transition at 767 nm and 770 nm.
- \bullet For Rb there is a $5s \to 5p$ transition at 780 nm and at 795 nm.
- \bullet For Cs there is a $6s \to 6p$ transition at 852 nm and at 894nm.

What is the origin of these doublets? The scaling of the splitting with the nucleus indicates relativistic origins and the splitting is indeed due to spin-orbit coupling, which we will discuss in the next lecture (sys).
